THREATS: ANNUAL AND PERENNIAL NON-TIMBER CROPS, LIVESTOCK FARMING AND RANCHING, MINING AND QUARRYING, RENEWABLE ENERGY, ROADS AND RAILROADS, UTILITY AND SERVICE LINES, HUNTING AND TRAPPING TERRESTRIAL ANIMALS, LOGGING AND WOOD HARVESTING, FIRE AND FIRE SUPPRESSION, HABITAT SHIFTING AND ALTERATIONS

CONSERVATION ACTIONS: CONSERVATION SITES HAVE BEEN IDENTIFIED AND PROTECTED AREAS EXIST. THE SPECIES HAS ALSO BEEN SUBJECT TO RECENT EDUCATION AND AWARENESS PROGRAMS, INTERNATIONAL MANAGEMENT/TRADE CONTROLS, LEGISLATION, AND EX-SITU CONSERVATION EFFORTS
